"Staff" means an employee of Centraal working at the Facilities.

"Member" means any person using the Facilities of Centraal

## 1. Membership

### 1.1 Acceptance and Responsibility

1.1.1 As a Member, you agree:

- a) To abide by all Centraal's rules, policies, and guidelines as communicated from time to time.
- b) To act respectfully toward other Members, Staff, and guests.
- c) To keep all membership details accurate and up-to-date.
- d) Attend the Facilities in attire that is deemed appropriate and comply with any rules communicated by Centraal in this regard.
- e) Not to bring any food of any kind into the Facilities without the prior permission of Centraal.
- f) That parking facilities are offered on a first come basis and cannot be guaranteed. Centraal reserves the right to request removal of Member(s)' cars.
- g) That family members named above as part of a Family Membership Package shall constitute Members subject to these Terms and that adult Members shall be responsible for and liable for the underage Members.

### 1.2 Registration and Fees

1.2.1 To become a member, you must complete the registration process and pay the applicable membership fees in accordance with the Membership Package chosen.

1.2.2 Membership fees shall be available at the reception and/or on Centraal's social media pages.

1.2.3 Membership fees paid are non-refundable. All details, relevant to your Membership Package, must be completed and clearly printed. Centraal reserves the right to unilaterally modify Membership Package.

1.2.4 One membership may bring up to three (3) guests per day. All guests must present a valid ID, be registered upon arrival, and remain accompanied by the member throughout their visit. A guest fee of BHD 2.200 per person will apply.

## 2. Use of Centraal's Facilities and Equipment

### 2.1 Access

2.1.1 Members have access to the Facilities, equipment, and programs during hours of operation, in accordance with their Membership Package. Hours of operation are subject to change. Access may be restricted due to maintenance, events, or other operational reasons.

2.1.2 Access shall be limited to Members as specified in the Membership Package. No additional guests shall be permitted.

2.1.3 Children under the age of 18 must always be accompanied by adults and remain supervised.

2.1.4 Children under the age of 18 are strictly prohibited from using or remaining in the Mix gym or Ladies gym. Access to these facilities is restricted to persons aged 18 years and above only.

### 2.2 Equipment Use

2.2.1 Members are responsible for using Centraal's equipment safely and responsibly. Any damage to equipment must be reported immediately.

2.2.2 Centraal reserves the right to charge for repair or replacement of damaged equipment caused by a Member.

2.2.3 Centraal reserves the right to suspend Members until such time as charges for repair or replacement have been paid.

2.2.4 Members are entirely responsible for the operation and safety of their own equipment not belonging to Centraal.

### 2.3 Personal Belongings

Centraal is not responsible for personal belongings left in the Facilities. Members should store their personal items in designated areas, and at their own risk. Centraal shall not be liable for any damage to, loss, or theft to personal items.

## 3. Health and Safety

3.1.1 Members must comply with all Ministry of Health of Bahrain (the "MOH") guidelines for the usage of the Facilities as published by the MOH. This includes, but not is not limited to, requirements for Members to be vaccinated, restrictions on number of Members, requirements on wearing masks, closure times, and other guidelines.

3.1.2 Members must follow all safety rules and instructions given by the Staff or coaches. Failure to comply may result in suspension or termination of membership.

3.1.3 All injuries and/or accidents must be reported immediately to the Staff.

3.1.4 Members must provide supporting information on health and safety issues where required.

3.1.5 In the event of a fire or emergency of any kind resulting in the need to evacuate the building, an alarm will sound and Members are required to leave the premises at the nearest signed exist and follow instructions provided by the Staff.

3.1.6 Centraal reserves the right to refuse access to the Facilities if it is deemed to be unsafe.

## **4. Conduct and Behavior**

### **4.1 Code of Conduct**

Members must always:

- (a) Behave in a respectful manner.
- (b) Disruptive, abusive, or inappropriate behavior towards other Members, Staff, or guests shall constitute a breach of these Term.
- (c) Refrain from conduct which is offensive, unseemly or unsporting, or which might cause annoyance or danger to others.
- (d) Comply with all Centraal policies and guidelines.
- (e) Comply with all instructions and requests made by Centraal.
- (f) Keep the Facilities clean and free from rubbish, garbage and any other waste.
- (g) Not use the Facilities in an illegal way.
- (h) Not use or possess alcoholic drinks or illegal drugs whilst on Centraal's premises.
- (i) Comply with any further rules enforced by Centraal.

### **4.2 Consequences for Misconduct**

In accordance with Clause 7.2, any Member who violates the code of conduct may face disciplinary action, including termination of membership, depending on the severity of the offense.

## **5. Events and Competitions**

### **5.1 Participation**

Members may have the opportunity to participate in events, tournaments, or competitions organized by Centraal. Participation may be subject to additional fees and/or registration requirements.

### **5.2 Event Cancellation**

5.2.1 Centraal reserves the right to cancel or reschedule events or access to the Facility at its discretion due to unforeseen circumstances such as weather, insufficient participation, maintenance or repair, closures required by the Ministry of Health, or other reasons beyond its reasonable control. Or if the Facilities are deemed unsafe. In such cases, Centraal will provide as much notice as possible.

5.2.2 Centraal will not be held liable for cancelation, rescheduling, or preventing access to the Facilities due to the reasons set out in 5.2.1 above.

## **6. Liability and Indemnification**

### **6.1 Liability**

By participating in Centraal's activities or using the Facilities, Members will enter and use the Facilities at their own risk. You agree to waive any claims against Centraal, its Staff, and affiliates for any harm, injuries, damages, destruction, or losses that may occur, save for those caused by gross or willful negligence, to the fullest extent permitted by law.

### **6.2 Indemnification**

6.2.1 You agree to indemnify and hold harmless Centraal, its employees, agents, and affiliates from any claims, damages, or losses arising from your actions, participation in activities, or use of the Facilities.

6.3.1 You agree to defend, indemnify and hold Centraal harmless from any and all claims, damages, liabilities, losses or actions, including costs, expenses and attorneys' fees, arising out of actions or claims by third parties, by reason of death, injuries to person or damage to property arising out of or relating to use of the Facilities or use of any equipment located on the Facilities, except in instances where Centraal has engaged in grossly negligent activities or willful misconduct.

9.3 Members do not have any right to create any lease, tenancy or interest in the Facilities.
